

# Technology-Based Clinical Supervision Skills-based Individual Presentations

# **Time to Perform Solo**

The hands-on, experiential practice portion of the series will begin in Week 4. For the individual presentations, each participant will be given a topic to demonstrate your level of competency using technology to provide clinical supervision. The presentation should be **8-10 minutes** in length and should focus on the topic as it relates to *Technology Based Clinical Supervision* (TBCS). You are being asked to create a **1-page working document** on your topic that will be used as the foundation for your presentation and starting steps to integrating TBCS within your practice. This foundational information and knowledge can be useful and shared with all participants at the end of the series.

After each presentation, there will be time for feedback from both instructors as well as the other participants.

## **Individual Skills-based Presentation Topics**

The topics below are TBCS best practice topics from *Using Technology to Enhance Clinical Supervision* by Tony Rousmaniere and Edina Renfro-Michel. Provided in the Toolbox is a chapter written by Dr. Rousmaniere for your reference <u>"Using Technology</u> <u>to Enhance Clinical Supervision Training."</u>

# **Presentation Guidance**

Using the topic assigned to you:

1. Develop a **1-page best practice document** on your topic that will be the foundation of your presentation.

- 2. Include information on how TBCS impacts your topic. For example:
  - what are items a supervisor needs to be aware of?
  - how does TBCS enhance this topic?
  - what are challenges TBCS causes within this topic?

You may also include your thoughts/perspective if your supervisee is using technology to provide services to clients. For example, here are suggestions on the topic of 'Diversity and Advocacy Considerations' that a supervisor would bring up to the supervisee:

- 1. The supervisor may work with the supervisee on how technology is viewed by different cultures and how this might impact client relationships.
- 2. The supervisor should be aware of Federal, State and Board specific regulations regarding the use of technology for both providing supervision and for their supervisee to provide counseling or other types of client services. This awareness should also include discussion on how to advocate for the use of technology as needed to provide better services.
- 3. The supervisor should discuss with the supervisee how various ways of direct observation might impact the supervisee and client from a cultural perspective.

During your presentation, use at least two (2) Zoom-specific functions such as:

- sharing your screen and showing a PowerPoint or document
- sharing your screen and showing an additional resource or website
- using the whiteboard
- using the chat

This is designed for experiential learning with the technology platform on a more individual basis.

## **Participation Expectations and Group Assignments**

Everyone is expected to:

- attend on your assigned presentation week
- complete the activity as assigned

This is an experiential series. To receive your CE credit and a certificate of completion for the series, this presentation activity is required to demonstrate the skills you have learned in this series. In addition, the preparation, planning, and actual demonstration require all participants to be involved and present. *If, for some reason, the dates will not work, or if you cannot commit to being present for this experiential phase of class, then email the NFARtec TBCS series administrator immediately.*
